**ORDER NO. 14**  
**ADOPTING PROCEDURAL SCHEDULE AND SETTING HEARING**


On August 18, 2020, Electro Purification, LLC (EP or Applicant) submitted an updated abatement status report and a proposed revised procedural schedule. Applicant indicated that all parties represented by counsel have agreed to the adoption of the proposed revised hearing schedule; and that one self-represented party has objected to it. As of the issuance of this order, no party has filed any objections or alternate proposed procedural schedule for the Administrative Law Judges' (ALJs) consideration. Therefore, the schedule is adopted as follows:

<b>August 31, 2020</b>	Deadline for Applicant to supplement prefiled testimony
<b>November 4, 2020</b>	Deadline for Protestants (except Commissioner Lon Shell) to supplement prefiled testimony
<b>November 18, 2020</b>	Deadline for Protestant Hays County to supplement prefiled testimony of Commissioner Lon Shell
<b>December 21, 2020</b>	Deadline for Barton Springs Edwards Aquifer Conservation District to supplement prefiled testimony
<b>December 28, 2020</b>	Deadline to schedule depositions
<b>January 15, 2021</b>	Deadline to file objections to prefiled testimony
<b>February 5, 2021</b>	Deadline to respond to objections to prefiled testimony
<b>February 8, 2021</b>	Deadline to respond to discovery – All written discovery must be served 30 days before deadline

<b>February 26, 2021</b>	Deadline for motions for summary disposition – responses due 15 days after a motion for summary disposition is filed.
<b>March 1, 2021</b>	Last day to conduct depositions (unless agreed to by parties and in such event no need to have ALJ modify schedule)
<b>March 15, 2021</b>	Deadline to request live prehearing conference
<b>March 22, 2021</b>	<b>Prehearing conference (by telephone unless otherwise agreed) at 10:00 a.m.</b>
<b>April 12-16 &amp; 19-20, 2021</b>	<b>Hearing on the merits – 9:00 a.m. each day</b>

The instructions in Order No. 3 regarding party alignment continue to apply. The hearing will convene at **9:00 a.m., April 12, 2021**, on the Fourth Floor of the William P. Clements Building, 300 West 15th Street, Austin, Texas, and will continue each weekday at 9:00 a.m. until completed, or no later than close of business April 20, 2021.
